Thereafter the applications will be called in order of seniority. These must be communicated by email to **NMphela@judiciary.org.za** prior to the hearing.
5. Parties are required to bring a hard copy of the draft order to court. Please ensure that the Judge's surname, date, case particulars and case number are correctly reflected on the draft order.
6. The draft order which is uploaded must clearly reflect the surname of the Judge, date of hearing, manner of hearing, the name of the counsel, the attorney and their respective e-mail addresses and the disclaimer. If the phrase "Further and/or alternative relief" appears in your draft order it must be deleted. Please ensure that there is compliance with the Judge President's Practice Directives.
