6. All draft orders in word and pdf format should be uploaded on caselines. Ensure that the draft orders comply with the Court directive and outline the Judges' name, date, mode of hearing including the following disclaimer:

"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be _____."
7. The Court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact the enrolment office. **If the matters are not visible on caselines and the bundles are not reflecting in order as to the sections on court online, the matter will be removed.**
8. Parties are to ensure that all documents inclusive of draft orders and practice notes are uploaded at least 3 days before the date of set down.
9. Where matters are settled or are to be removed, ensure that a note to that effect is made timeously on caselines, a notice of removal is served and uploaded and/or a draft order encapsulating the removal terms/ settlement terms is uploaded and handed up to Court.
