DIRECTIVE FOR FAMILY COURT BEFORE JUDGE POTTERILL – 24-28 FEBRUARY 2025

1. Kindly find attached the allocated Family Court roll for the week of 24 February 2025.
2. Please contact in Ms. Esther Rikhotso at ERikhotso@judiciary.org.za in relation to Judge Joyini's roll.
3. No further documents may be uploaded to Caselines except for draft orders.
4. Any matters that are not in order will be removed from the roll.
5. The allocation before Judge Potterill is as follows:
 - **Monday 24 February 2025 at 10:00** – all the unopposed divorces appearing on the allocation roll of Judge Potterill
 - **Tuesday 25 February 2025 at 10:00** – all the Rule 43 matters and urgent family court matters on the allocation roll of Judge Potterill
 - **Wednesday 26 February 2025 at 10:00** – all the other family court matters on the allocation roll of Judge Potterill

6. The matters which are allocated to Judge Potterill will be called **physically in court and the hearing will begin strictly at 10:00**. Parties are to verify the court venue on the date of hearing.

9. Draft orders are to be uploaded to Caselines by 13:00 one court day before the hearing i.e. draft orders in matters to be heard on 24 February 2025 should be uploaded by 13:00 on 21 February 2025.
10. **Counsel are required to bring a hard copy of the draft order to court and the settlement agreement where applicable. Please ensure that the Judge's surname, date, case particulars and case number are correctly reflected on the draft order.**
11. The draft order which is uploaded must clearly reflect the surname of the Judge, date of hearing, manner of hearing, the name of the counsel, the attorney and their respective e-mail addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
