OPPOSED MOTIONS DIRECTIVE: 3 – 7 MARCH 2025
MATTERS BEFORE HONORABLE BERGER AJ

TO : ALL LEGAL PRACTITIONERS

1. Kindly note that the matters detailed in the attached opposed motion roll have been allocated to Berger AJ.
2. All matters will be heard in open court, unless consensus on a virtual hearing is reached between counsel appearing in the matter, and the court is of the view that the matter ought to proceed virtually. For those matters that will be heard in open court, the parties will be informed of the courtroom prior to the hearing.
3. All documents in each matter, including in particular each party's heads of argument and the joint practice note, must – if not yet done – be uploaded onto CaseLines by no later than 12h00 on Monday, 24 February 2025. Electronic copies of the heads of argument and joint practice note must also be emailed to MMoropa@judiciary.org.za by the same time.
4. Subject to the deadline in paragraph 3 above, counsel should ensure that the joint practice note satisfies the requirements set out in paragraph 25 of the Judge President's Consolidated Practice Directive of 2024. Should a joint practice note

not be filed, the parties must each file a separate practice note in which an explanation is provided as to why a joint practice note could not be filed. The practice note must indicate under which sections on CaseLines the relevant papers to be read are to be found.

5. Parties must file a chronology of relevant events either as part of or together with the joint practice note (or separate practice notes, where applicable).
6. Parties must email draft orders (in Word format) to MMoropa@judiciary.org.za at least 24 hours before a particular matter is to be heard and upload them onto CaseLines. A hard copy of each draft order must also be brought to court.
7. Where matters are to be removed, postponed, or have become settled, the parties must inform the judge's secretary as soon as is reasonably possible.
8. Introductions are not necessary, and parties may introduce themselves on the calling of their matters.
