 - Odd numbered matters (i.e. 1, 3, 5 etc.) will be heard before Acting Judge Minnaar
 - Even numbered matters (i.e. 2, 4, 6 etc.) will be heard before Acting Judge Mazibuko.
3. The allocation before Judge Mazibuko is the following:
 - Monday, 24 March 2025 at 11:30 – all even numbered unopposed family court Matters
 - Tuesday, 25 March 2025 at 10:00 – all even numbered opposed family court matters and urgent family court matters will be heard
4. NO further documents may be uploaded on Caselines!
5. In unopposed divorce matters where there are minor children, viva voce evidence is required.

6. In matters where there are no children, and no evidence affidavit was uploaded by 16h00 on 20 March 2025 – viva voce evidence is required.
7. All matters will be heard in open court on Monday at 11:30 and on Tuesday at 10h00 (please see the day-roll for the court that will be used for the hearing).
8. All introductions will be done in open court.
9. Parties are reminded to ensure that the case number, roll number and parties names on the draft orders are correct as well as all annexures.
10. Only 1 draft order is required to be handed up.
11. The general Family Court Directives are to be STRICTLY complied with.
12. Kindly circulate this directive to all necessary parties.
