PLEASE NOTE THAT THE PRESIDING JUDGE HAS DIRECTED AS FOLLOWS:

1. All matters set down for 25 March 2025 will be called on Tuesday (25 March 2025) at 10h00 and all Legal Practitioners are to attend roll call unless excused. All matters will be heard in Physical Court 9E.
2. Practice Notes and/or Heads of Argument must be e-mailed in Word version in matters allocated to Pretorius AJ to GLebelo@judiciary.org.za in all matters by all the parties **as soon as possible** but no later than 12h00 on Monday, 24 March 2025.
3. Counsel are requested to ensure that all relevant Practice Directives are promptly complied with. If a matter is not progressing or has been settled, Pretorius AJ's secretary should be notified without delay.
4. The Judge may communicate with the parties' representatives through widely shared notes posted on Caselines. Legal representatives should carefully review these communications and respond promptly.
5. Legal practitioners are reminded of the content of the notice dated 4 October 2021, circulated by the Deputy Judge President to the professions regarding the urgent motion

in court. A copy of this notice is attached.

6. Legal Practitioners are responsible for ensuring that all documents related to each matter are available on the Caselines platform. They should confirm with the secretary of Pretorius AJ whether access has been granted to the relevant file.
