1. Kindly note that all family court matters which will be before Madam Justice Fitzroy, for the week of 14-18 April 2025 will be heard in **Open Court at 10h00 unless otherwise directed.** (Details of the court allocated should be checked on the day roll)
2. Matters have been allocated as per the roll below and counsel need only appear on the day allocated.
3. Plaintiffs in unopposed divorce matters **where there are no minor children** are as a general rule, not required to appear in person in which case, an uploaded evidence affidavit will suffice. However, should no evidence affidavit be upload alternatively, if the Family Advocate has not endorsed the settlement agreement and/or raised a query, the Plaintiff **MUST** be ready to testify.
4. All parties testifying **MUST** be suitably dressed for Court.
5. Parties must ensure that a case profile is created for their matter on Caselines and all relevant documents must be uploaded thereon before **12h00 on the Thursday, before the week in which your matter is enrolled. No further papers will be considered after 12h00 on that Thursday, nor are documents to be uploaded without the Judge's leave, and except when a note has been published by the Judge requesting a further affidavit / practice note to be filed .**
6. If a **draft order** is to be made an order of court, **one hard copy** must be brought to be handed up in court. **Draft Orders and settlement agreements**, if applicable, must correctly indicate the Judge's name (i.e. FITZROY AJ), date on which the matter was heard, in which court and at the end of the draft order the party must indicate the name

and contact details of their counsel and their instructing attorney.

7. Introductions to the Judge shall take place at **09H30** in Judges Chamber on the Second floor at the High Court (Pretoria)
