RE : NOTICE in re: SUMMARY JUDGMENT HEARINGS IN

**JOHANNESBURG** 

- 1. This notice advises legal Practitioners of changes to the hearings of summary judgment applications. The changes are effective from week 1 of term 3 of 2025.
- 2. Hitherto the summary judgment cases have been tagged onto the general opposed motion roll. This means that, at present, there are some summary judgment applications set down as far ahead as February 2026. This lead time is incongruent with the purpose of summary judgment remedies.
- 3. Henceforth, there shall be a dedicated summary judgment court which shall sit each week of the term to hear both opposed and unopposed summary judgment applications.
- 4. To overcome the long lead times certain cases that are set down in the 4<sup>th</sup> term of 2025 shall be transferred to the third term and the matters set down in the 1<sup>st</sup> term of 2026 shall be transferred to the 4<sup>th</sup> term of 2025. The revised set-downs are thus:

- 5. Third term and fourth term of 2025:
  - 5.1. In week 1 and 2 of the Third term the summary judgment matters enrolled in the opposed motion court and the unopposed motion court shall be heard in the dedicated summary judgment court.
  - 5.2. From week 3 of term 3 onwards, summary judgment matters enrolled in the opposed motion court and the unopposed motion court shall be heard in the dedicated summary judgment court and in addition the summary judgment cases enrolled in weeks 3 to 9 of the fourth term shall be transferred to weeks 3 to 9 in the third term.
  - 5.3. The summary judgment cases enrolled in weeks 1 and 2 of the 4<sup>th</sup> term shall remain where they are and be heard in those weeks in the 4<sup>th</sup> term.
- 6. Fourth term of 2025 and first term of 2026:
  - 6.1. All summary judgment cases already set down in term 1 of 2026 shall be transferred to the respective same week in term 4 of 2025; i.e., week 1 to week 1, week 2 to week 2 etc.
  - 6.2. All requests for enrolment of summary judgment applications made from 17 June 2025 onwards, can now be set down from the fourth week of term 4. This reduces the lead time from 23 weeks (excluding recesses) to 13 weeks.
- 7. The number of opposed summary judgment applications is capped at 10 per week.
- 8. The number of unopposed summary judgments is uncapped.
- 9. All cases shall formally be enrolled on the Monday of the week. The presiding judge shall dispose of the unopposed cases on Monday and direct when opposed matters shall be heard during the balance of the week.
- 10. The enrolment requirements to be issued a set down date of an opposed summary judgment application remain unchanged and continue to be regulated by the amendments to para 25 of the Practice Directive 1 of 2024, as published on 8 April 2025. Attention is drawn especially to para 25.4:

'25.4 The opposed motion roll shall close at noon twenty (20) clear court days

preceding the hearing date, including opposed applications for

summary judgment enrolled in the opposed motion court'.

A copy of the directive of 8 April is attached hereto.

11. When an opportunity presents itself, a special big bang shall be arranged to

reduce the summary judgment lead-time to 4 weeks.
