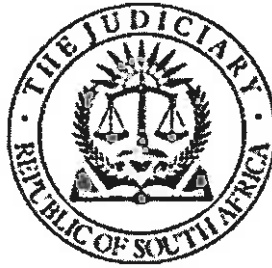

JUDICIAL CASE MANAGEMENT CONFERENCES BEFORE DE VOS J FOR THE WEEK 09 – 13 NOVEMBER 2020

Kindly note that the following procedure will apply in Judicial Case Management Conferences enrolled before De Vos J during the week 09 – 13 November 2020:

- [1] Only matters which have been registered on CaseLines and of which documents have already been uploaded; and/or matters where the court file has been received from the Registrar, will be considered.
- [2] There are several matters to which we do not have access on CaseLines. If we do not have access to the matter on CaseLines, we also do not have access to the Form 10. Please make sure that a CaseLines invitation was sent to zjansen@judiciary.org.za.
- [2] A fully completed Form 10 must be uploaded to CaseLines. All the information required on the Form 10 must be provided.
- [3] Practitioners are encouraged to also indicate the following on the Form 10:
 - [a] In the event that merits have not yet been settled and merits and quantum are to be separated, why the matter should continue on merits only;
 - [b] All expert reports already filed by plaintiff and/or defendant (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10);

- [c] Outstanding expert reports still to be filed by plaintiff and/or defendant (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10);
- [d] When outstanding expert reports (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10) will be filed.
- [e] Any other issue not referred to above for consideration by the Judge.
- [4] Where a matter is simply to be removed from the roll, kindly indicate same.
- [5] Only Form 10's which have been uploaded onto CaseLines under a separate and clear heading will be considered. In the event that a Form 10 cannot be uploaded an arrangement can be made to e-mail same to zjansen@judiciary.org.za / zonika.ptahighcourt@gmail.com.
- [6] The rolls for the week 09 – 13 November are attached hereto. Forms should be uploaded in advance and must be available on CaseLines by 09h00 on the date of enrolment. Kindly indicate the date of enrolment as well as the roll number on the form.
- [7] All matters will be finalised on the papers, and no video conferences will be arranged. However, practitioners must be available for telephonic enquiries if the need arises. A finalised roll, on which the outcome of each case is indicated, will be forwarded to all relevant legal practitioners via email in due course.
- [8] Hard copies of the signed Form 10 in matters which have been certified will be available for collection from this office after the finalised roll has been circulated. No signed Form 10's will be uploaded to CaseLines or sent by way of email. Copies of the certified Form 10's will be filed by this office for record purposes.
