JUDICIAL CASE MANAGEMENT MEETINGS: STEENEKAMP AJ for the week of 29 March 2021 to 1 April 2021:

The following directive is issued in respect of the JCMM'S for the week of 29 March 2021 to 1 April 2021.

1. The complete Form 10 is to be uploaded to CaseLines and, in addition, all completed Form 10's are to be emailed to [Pvilakazi@judiciary.org.za](mailto:Pvilakazi@judiciary.org.za) and [innes@irsattorneys.co.za](mailto:innes@irsattorneys.co.za) by no later than 11h00 on the day prior to the JCMM. The number on the roll, and the date on which your matter appears on the roll example: Nr.23 of 30 March 2021 must be clearly indicated on the form 10;
2. All practitioners are to ensure that the Form 10 has been comprehensively completed and, where necessary, supplemented with the following (where applicable separately):
  1. If merits are in dispute the reasons must be provided (to be provided separately);
  2. If any of the exper reports are still outstanding: which are outstanding and when will they be filed? (indicated on the Form 10)
  3. If joint minuted are outstanding: which are outstanding and when will they be filed? (indicated on the Form 10)
  4. How many days are needed for trial? (indicated on the Form 10)
  5. if the date for trial has been furnished, please indicate this on the Form 10.
3. No hearings are required on the date the JCMM is enrolled, meetings will be adjudicated on the papers and parties will either receive the signed Form 10 via email or will be notified that certification is refused;
4. Should the Honourable Justice Steenekamp experience any problems with your matter, a virtual court meeting will be arranged and the parties will be notified accordingly.
5. Should your Form 10 be in order, it will be signed, stamped and uploaded onto CaseLines.
6. Should your matter become settled, kindly also email Judge Steenekamp AJ at [innes@irsattorneys.co.za](mailto:innes@irsattorneys.co.za), explain the situation and ask that the matter be removed.
