  - 1.3 No readiness certificates will be granted where such applications for a JCM date was made after 18 February 2021 (subject to the right of the representatives to address the Court as per 1.5 below)
  - 1.4 Parties are instructed to avail themselves of the procedures as set

out in the directive.
