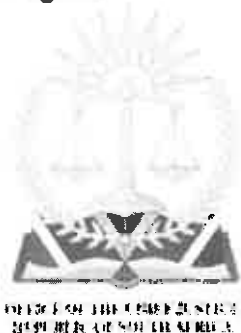
Good day
