**JUDICIAL CASE MANAGEMENT CONFERENCES / SETTLEMENT COURT /  
DEFAULT JUDGMENT ROLLS**  
**22 AUGUST 2022 TO 26 AUGUST 2022**  
**BEFORE ACTING JUDGE MAZIBUKO**

1. Please note that the matters will be heard in an open court (Court 8A).
2. The court will follow the following sequence: It will commence with the Settlement roll, default judgment matters and the Case management roll.
3. All documents must be uploaded onto Caselines, and Counsel are expected to appear in an open court unless a Notice of removal is timeously uploaded onto Caselines.
4. Please ensure strict compliance with Chapters 4 and 5 of the Judge President's Revised Practice Directives 1 of 2021 and ensure that all the relevant documents are uploaded onto Caselines in respect of the matters.
5. Parties are to ensure that they **(a) UPLOAD** their **DRAFT ORDERS / FORM 10** onto Caselines in (i) word and (ii) PDF format, and **(b) BRING** a hard copy of the draft orders they wish to move.

6. Where the draft orders pertain to a matter on the **settlement roll**, please upload letters of confirmation by the Defendant that they have perused the terms of THAT draft order and are satisfied with the terms therein. In respect of contingency agreements please have the prescribed confirmatory affidavits as required. Failing which, the draft will not be made an order of court.
7. Should there be any amendment on the draft order or Form 10, parties must upload same onto Caselines in both word and PDF formats before end of business on the same day of the hearing.
8. All draft order must indicate when the matter was heard, the Judge's name (i.e. Acting Judge Mazibuko), in which Court and, at the end of the draft order, the party must indicate the name and contact details of both counsel and their instructing attorneys.
9. Parties must comply with directives so that matters are not removed or struck off the roll.
