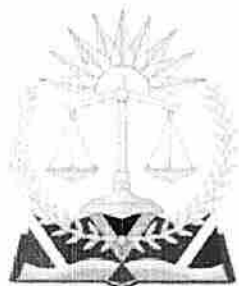

DIRECTIVE:

JCMC MATTERS:

3. Parties must upload a copy of their **FORM 10's** onto Caselines and also email a copy in word format to: **DMalimakoe@judiciary.org.za** a day before the day of hearing. Should the Judge order any amendments to the Form 10, parties must forward same to the email address provided above.
4. Attorneys have the responsibility to ensure that the Form 10 is correctly completed.

TRIAL DEFAULT JUDGMENTS:

1. **Draft Orders** indicating the correctly Judge's name (i.e. **Meersingh AJ**), date on which matter was heard and also the name and contact details of counsel and their instructing attorney, must be uploaded onto Caselines. On the top right corner of the page it must indicate the number on the roll on which the matter appears.
2. Practitioners are to ensure that all necessary documents are filed and uploaded on Caselines in all matters.
3. Failure to adhere to these directions will result in the matter being removed from the Roll.
