**BEFORE COLLIS J**

1. Kindly take note that all matters will be dealt with by way of Microsoft Teams commencing at 10h00. See below Microsoft Teams link. Same will also be uploaded on Caselines.
2. The court will commence with judicial case management meetings and conclude with default judgment matters.
3. Parties should ensure that all documents are filed on Caselines **by no later than close of business on the day before the hearing date.**
4. Draft orders and your Form 10 should be uploaded on Caselines in both PDF and Word format.
5. Draft orders should contain a disclaimer, indicating the date of hearing, Judges' names (i.e Collis J), manner of hearing (i.e Microsoft Teams) and the name and details of Counsel/Practitioner and those of the instructing attorney.
