DIRECTIVE FOR MATTERS BEFORE MADAM JUSTICE KHUMALO

Re: JCMC and Default Judgments 3 to 7 Oct 2022

1. Kindly take note that the judicial case management matters will be decided on paper only, no need for any appearance. The correct Form 10 must be available on Caselines timeously, 24 hours before the time of set down, failing which the matter will be removed. An outcome roll will be circulated with reason if in the event that matters is not certified.
2. Default judgments will be heard virtually on the MS Teams platform. The plaintiff must ensure the availability of witnesses. A link will be sent the morning of the day the matter is placed and will also appear on Caseline as a 'widely shared note'. Counsel is urged, when directed by the court, to upload amended draft orders the same day, failing which will only cause a delay in obtaining the court order.
