20-23 JULY 2021 URGENT APPLICATION ROLL BEFORE THE HONOURABLE MADAM JUSTICE NEUKIRCHER J

Kindly note that an allocation **DOES NOT MEAN** that the matter is considered to be urgent. Argument will still need to be made re the grounds of urgency.

All hearings will take place via Microsoft Teams. The link will be provided by Ms Msimanga. Counsel are to be logged in by no later than 09h50 on the date of hearing indicated on the roll. Please ensure that you are properly robed, that the camera is off and microphone muted until you are called on to make submissions. Please ensure there is no window behind you as the light is disturbing and distorts the video feed.

Where parties have failed to provide practice notes and/or a certificate of urgency by Thursday 15 July 2021 or if the papers are not fully complete when the roll closed on Thursday 15 July 2021 the papers are not considered to be in order (the practice directive circulated refers). No party may file any affidavit, practice note or certificate after 15 July 2021 without the express permission of Judge Neukircher. No piecemeal filing of documents will be allowed and the court bundle will be frozen.

Where no caselines link was received by close of business on Thursday 15 July 2021, the matter is not ripe for hearing. If a party was unable to create a link an affidavit is to be emailed to Ms Msimanga with a full explanation as to the attempts made to create

the link and upload to caselines and, where considered appropriate, Judge Neukircher may then give directions as to the filing of papers.

No party is permitted to email Judge Neukircher directly and any such communication **WILL BE IGNORED**. All communication is to take place via Judge Neukircher's registrar at zmsimanga@judiciary.org.za.

In all opposed matters where the papers are complete by close of roll on Thursday 15 July 2021, heads of argument are to be emailed to Ms Msimanga by no later than 12h00 on Monday 19 July 2021. Where these have already been uploaded to caselines, those heads will suffice.
