1. Kindly be advised that where no certificate of urgency has been filed and/or no practice note has been filed the matter will be struck from the roll.
2. In matters that are unopposed or settled-draft orders in word format are to be emailed to the relevant Judge's registrar by no later than 13h00 on Monday 29 March 2021. No hearing is required for these matters unless parties notify the relevant Judge's registrar otherwise or the particular Judge requires submissions. Counsels are to remain available.
3. In all opposed matters, heads of argument are to be filed by both parties before 12h00 on Monday 29 March 2021. Strict regard will be applied to the rules of urgency.
4. All hearings will take place via video conferencing. The Applicant in each matter is tasked with providing the Judge's registrar with their email addresses for Microsoft Teams (link) hearing.

5. If parties are of the view that a matter may be heard on the papers and without a hearing, they are to indicate this to the Judge's registrar by no later than 10h00 on Monday 29 March 2021.
6. An allocation does NOT mean that the matter is considered sufficiently urgent to hear on the merits. Submissions will need to be made regarding the grounds of urgency.
7. If there is non-compliance with this directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
