URGENT COURT ROLL DIRECTIVES FOR MATTERS BEFORE MBONGWE J: 29 AUGUST 2022

1. Kindly find the attached Urgent court roll for matters to be dealt with by Judge Mbongwe on 29 August 2022.
2. Kindly take note that roll call shall take place in open court, Court 6C. The proceedings will commence at 10h00 on the day.
4. All cases **MUST** be uploaded on Caselines. If any problems are experienced, the Judge's Registrar may be contacted **TIMEOUSLY**.
3. A practice note must be filed on Caselines setting out the following:

- a. The grounds for urgency;
 - b. The nature of the application;
 - c. The estimated duration of the matter;
 - d. If there is non-compliance with the JP's directives issued for the urgent court, the reasons for such deviation must be stipulated;
 - e. Parties should ensure that a compliance declaration is uploaded onto Caselines;
 - f. Contact details of the legal practitioners, which must include both cellphone numbers and addresses;
4. Where no certificate of urgency has been filed and/or no practice note has been filed the matter will be struck from the roll unless good cause is shown for non-compliance as per the issued directive.
 5. The Draft Order/s must be in both Word and Pdf format and uploaded unto case lines. The hard copy of the Draft order is required in court on the day.
 6. Notices of removals should be uploaded onto Caselines and emailed to the email provided below.
