1. Kindly find the attached allocated Urgent Applications for matters to be dealt with by Acting Judge Ndlovane.
2. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams. The Roll Call will commence at 10h00 using Microsoft Teams.
