- [2] If there is non-compliance with the practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- [3] There will be no roll-call on Tuesday 3 May 2022. Matters are allocated a date and Virtual court hearings will start at 10h00 every day unless specifically otherwise stated. Legal practitioners are urged to log on to the MS Teams virtual hearings at the time slots indicated on the roll below. The time slot allocated is in accordance with the duration indicated in the practice note.

- [4] An allocation does **NOT** mean that the matter is considered sufficiently urgent to be heard on the merits. Submissions will need to be made regarding the grounds of urgency.
- [5] It is the parties' responsibility to obtain dates from the registrar for return dates.
- [6] If there are any removals, settlements prior the hearings, notice should be sent to the Registrar by email.
