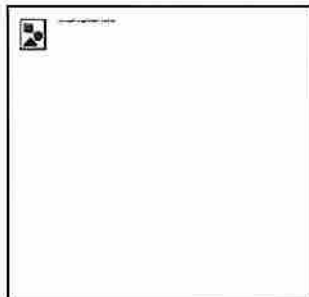

5. In respect of those matters where reliance for the relief sought is placed on a Statute, Regulations or any particular case/s, copied of thereof (or where the

document is long the relevant portions) and the case must be uploaded to Caselines.

6. Counsel are reminded that applicants must upload to Caselines a draft order containing the relief sought in **MS Word format**. Matters will not be entertained in the absence thereof.

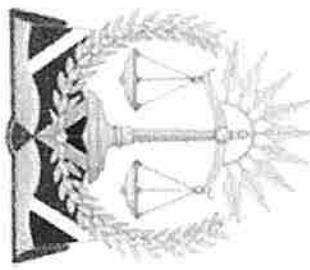
