2. In the interim and to assist the above-mentioned Judge, please note the following:

- 2.1. To assist the Judge in the deliberation of the matters on his roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions.
- 2.2.
