**CIVIL TRIAL DEFAULT JUDGMENT**

**PLEASE TAKE NOTE OF THE FOLLOWING:**

1. All matters will be heard in the allocated open court, commencing at 10h00 each day.
2. Introductions will take place in court.
3. Removals and postponements should be communicated timeously by email to [GLEbelo@judiciary.org.za](mailto:GLEbelo@judiciary.org.za) as soon as Counsel and/or the Attorney becomes aware thereof. Practitioners are furthermore requested to make a widely shared note of such intended removal on Caselines.
4. The roll will be dealt with as follows:
  - 4.1 Removals;
  - 4.2 Settlements;
  - 4.3 The roll will thereafter be called according to the seniority of the Advocates and/or Attorneys appearing in the matter;
  - 4.4 Practitioners are requested to upload succinct Heads of Argument and the proposed Draft Order (in both PDF and MS Word formats) onto Caselines no later than 12h00 on the day preceding the hearing of the matter;

4.5 Kindly create a separate bundle named **DIRECTIVE COMPLIANCE**, which must include the following documents **in the same stipulated sequence** (no hard copies thereof will be accepted during court proceedings):

- 4.5.1. Compliance Affidavit;
- 4.5.2 Practice Note;
- 4.5.3 TIC Order;
- 4.5.4 Proof of Service of the TIC Order;
- 4.5.5 Notice of Set Down and Proof of Service;
- 4.5.6 Draft Order; and
- 4.5.7 Contingency Fee Agreement and requisite affidavits (if applicable).

5. For matters that have become settled, practitioners are requested to create a separate section named **SETTLEMENT DOCUMENTS**, in the same stipulated sequence:

- 5.1 Offer and Acceptance;
- 5.2 Draft Order;
- 5.3 Confirmation Letter; and
- 5.4. Contingency Fee Agreement and requisite affidavits (if applicable).

6. Practitioners are requested to provide 1 **(one) hard copies of the Draft Order** for hand-up in court. The following disclaimer must be included in every Draft Order:

*“This Order is made an Order of Court by Judge Ryneveldt AJ, duly stamped by the Registrar of the Court, and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Caselines by the Judge or his Secretary. The date of this Order is deemed to be \_\_\_\_\_.”*
