JUDGE'S DIRECTIVES

3. Parties are reminded to ensure that they have complied with the relevant practice directives and rules of this court, and that any deviation therefrom is properly substantiated. Parties' attention is specifically drawn to paragraphs 28 of Revised Consolidated Practice Directive 1 of 2024.
4. Parties must further comply with the directive pertaining to the rules for the Dedicated Insolvency Motion Court and the Dedicated Insolvency Trial Court in the Johannesburg High Court, with effect from term 2 of 2025.
5. Parties should upload a compliant Practice Note stating the nature of the application, the date on which the application is on the roll, and the counsel's and attorney's names and contact details, Notice of Final Enrolment with proof of timeous service of same, and a Draft Order on CaseLines.
6. All draft orders in word and pdf format should be uploaded on CaseLines. Ensure that the draft orders comply with the Court directive and outline the Judges' name, date, mode of hearing including the following disclaimer:

"This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or her Secretary. The date of this Order is deemed to be _____.

7. Where matters are settled or are to be removed, ensure that a note to that effect is made timeously on caselines, a notice of removal is served and uploaded and/or a draft order encapsulating the removal terms/ settlement terms is uploaded and handed up to Court.
