DIRECTIVES IN RESPECT OF UNOPPOSED MOTIONS BEFORE VAN ASWEGEN AJ

1. The unopposed motions before VAN ASWEGEN AJ will be heard physically in open court.
2. Court will start at 10:00, starting with removals and postponements.
3. Introductions will be done in court. Practitioners are kindly requested to not attend to the judge's chambers in terms of the internal directive regarding new security measures dated 17 October 2025.
4. Counsel will be heard in order of seniority.

5. Parties must ensure that the files on CaseLines comply with paragraphs 7, 24 and 26 of the Revised Consolidated Practice Directive 1/2024 and any other paragraphs that may be relevant to that matter, **by 16h00 on Thursday, 02 April 2026**, failing which the matter is at risk of not being dealt with.
6. Should any of the parties have any doubts about the correct directive, please contact Ms N Masilela through her email.
7. A compliant Practice Note relevant to this hearing, and properly labelled, must be uploaded by no later than **16h00 on Thursday, 02 APRIL 2026**.
8. Draft Orders (**TO BE HEADED: COURT ORDER/ ORDER**), are to be uploaded in Word format. The matter number on the roll, the date of hearing, the Judge's name (**VAN ASWEGEN AJ**) must be populated in the Draft Order.
9. In addition to uploading, practitioners are to present one hard copy of the Draft Order when their matters are called.
10. Notice of Removals should be emailed to NeMasilela@judiciary.org.za for matters that are to be removed by notice, as soon as possible (in addition to uploading).
11. All correspondences & communication is to be limited to the above email address.
12. Please advise Ms N Masilela as soon as possible on the above email address if, for any reason, the judge should not read the papers in the matter.
13. Litigants with matters not yet bundled to CaseLines are to ensure that their matters are bundled and migrated to CaseLines by no later than **16h00 on Thursday, 02 APRIL 2026** and to advise via email once migration has been done.
14. **Litigants are reminded that it is their responsibility to ensure compliance, and that no reliance should be placed on the failure of the roll to indicate that there is non-compliance.**
