5. Further inform the registrar of any removals in time through the email address RMahori@judiciary.org.za
6. All parties in unopposed matters are to required to file a recently dated practice note. If the practice note do not reflect the reflect Caselines by no later than the end of the court day on Friday, 13 March 2026, it may result in removal of the matter on the roll.
