

DIRECTIVE FOR DEFAULT JUDGEMENTS TRIAL COURT PROCEEDINGS

BEFORE THE HONOURABLE ACTING JUSTICE THERON FOR 18 MAY 2026 -22 MAY 2026

1. All matters will be heard at 09:30 am. Matters will be heard virtually via Teams. The link will be published each week.

2. The Caselines profile and sections must be sensible and chronologically numbered, so that the relevant sections are on top (the Default Judgment hearing items first). Compliance with the form and style dictated in paragraph 7 of the Consolidated Practice Directive is expected.

3. Draft orders and heads of argument must be uploaded before 12:00 one day before the hearing date. Please make sure there are no typographical errors on the draft orders and that they are completed in full.

4. Heads of argument may not be longer than **20 pages**, preferably 15 or less. Judges tasked with default judgments in this division have to read through numerous cases' reports and documents. There is simply not enough time to read unnecessarily voluminous heads.

5. Removals and settlements will be called first. Thereafter other matters will be heard according to the seniority of counsel.

6. Matters that have become settled: A separate profile called SETTLEMENT BUNDLE must be created containing the following:

- * Offer and acceptance
- * Confirmation letter in respect of the draft order
- * Draft order

7. In the event of a removal:

- Counsel must give a full explanation for the removal (other matters could have been finalised in its place). Prepare on costs.
- A draft order must be uploaded.

8. In the event of a removal or postponement, the judge's registrar must be informed timeously, in order to inform the judge not to read the papers. Please email all correspondence to DMakgeru@judiciary.org.za.
