DIRECTIVES

1. HEARING DATE; TIME; AND, MODE

- (a) All matters will be heard in open court on 20 July 2026.
- (b) Introductions, where necessary, shall be in Court.

2. APPEARANCE & REMOVAL NOTICE

- (a) Appearance will be required in all matters, save for those that had duly been removed by notice.
- (b) Removal notice(s) must, thus, be accordingly uploaded, failing which, counsel is expected to appear in the matter.

3. ACCESS/ INTERFACE BUNDLE/ PRACTICE NOTE(S)

(a) Parties are to ensure that:

(i) all of their matters are accessible on CaseLines by both the presiding Judge and his/her Registrar, including those that were initiated and interfaced from Court-OnLine;

(ii) an updated Practice Note (of a joint nature, where applicable) is timeously uploaded; and,

(iii) a complete set of papers has been uploaded.

(b) In the case of inaccessibility, the matter will be deemed as unripe for hearing and, thus, up for removal until and/or unless the applicant moves, as swiftly as possible, to cure the defect thereof, as well as justifying why the matter concerned should not be removed.

4. COMMUNICATION VIA WIDELY SHARED NOTES ON CASELINES

(a) The Judge may post queries via widely shared notes posted on the electronic file.

(b) Legal representatives are to look out for these communications and are requested to briefly respond to such communications.

5. DRAFT ORDER(S) & HEADS OF ARGUMENT

(a) A proper and complete Draft Order, indicating the date and particulars of the Judge must be filed on Court-On-Line/ CaseLines for the Court to consider.

(b) Heads of Argument, where and if applicable or necessary, must be accordingly filed.
