6. Counsels are to ensure that there is compliance with the relevant practice directives pertaining to default judgments.

7. **Draft orders should contain the number of the matter on the roll and the name and details of both counsel / practitioner and that of their instructing attorneys are to be indicated.**
8. **As soon as the order is granted counsels/ practitioners should email the final order to the secretary to MRammutedi@judiciary.org.za.**
9. **Notices of removals must be emailed to MRammutedi@judiciary.org.za no later than 21 August 2026 in which case, Counsel will automatically be excused from Court. Matters not so removed will be struck from the roll in the case of non-appearance.**
