**RE: NOTICE IN RESPECT OF CIVIL TRIAL MATTERS ALLOCATED FOR
RECESS PERIOD 01 OCTOBER 2024 – 04 OCTOBER 2024.**

1. With reference to Notice 401 of 2019 as published in the Government Gazette No; 42605 dated 31 July 2019, the preceding Chief Justice of the Republic of South Africa Mogoeng Mogoeng, issued directive 2 of 2019 In terms of which the date of 23 September 2024 - 6 October 2024 is reserved for the recess period in the Superior Courts.
