Directives:

1. Kindly take note that the following matters have been allocate to Engelbrecht A.
2. All matters will be heard in open court, unless consensus on a virtual hearing is reached between counsel appearing in the matter and the court is of the view that such matter may be heard virtually.

- 3. In virtual hearings, the links will be created by the secretary of the judge to whom the matters are allocated and posted to the individual judges' rolls.**
- 4. All documents in each matter, including party's heads of argument and joint practise notes must be uploaded no later than 12:00 on 25 February 2025 (if not already done).**
- 5. Should parties remove their matter from the roll, parties are to email the relevant Judge's Secretary a notice of removal timeously and are to upload the Notice to the electronic file.**
- 6. Subject to the deadline in paragraph 4 above each party must explaining why such joint practise note was not uploaded in terms of the provisions of the Consolidated Practice Directive 01 of 2024 which came into effect on 26 February 2024 (amended on 12 June 2024). Practitioners are urgent to acquaint themselves with the content thereof and in particular paragraph 25. Kindly note that the time period for the filing of a joint practice note has been amended from five (05) to twelve (12) court days (paragraph 25.18).**
- 7. Parties must also file a chronology of events as part of the joint practise note or in a separate documents.**
- 8. Court Orders should be emailed to the secretary of the judge to whom the matter is allocated in Word format. Please check the details of the parties (particularly reference numbers, erf numbers, identity numbers, case numbers). Also, please append the details of counsel (including their email address and cell phone numbers) at the bottom of the court order.**
- 9. Introductions are not necessary and may be done in court when calling their matters.**
