1. Save as otherwise indicated, the matters below will be called in open court in the order that they appear on the roll, at **10h00** on **FRIDAY 2nd of May 2025**. If counsel is not present and has not been excused when the matter is called, the matter will be moved to the end of the roll and called again. If counsel is not present when the matter is called for a second time, the matter will be removed from the roll.
 2. All material documents to be placed before the court, including practice notes and draft orders, must be uploaded to Court Online and then made available on **Caselines** by no later than **noon** on **Wednesday 30th April 2025**, failing which the matter may be removed from the roll.
 3. It is emphasised that the parties are required to make their documents available on the **Caselines** system. The parties or their legal representatives must ensure that the Court Online entry is set so as to ensure that the whole file is available on **Caselines**. Matters not accessible on **Caselines** will be removed from the roll.
 4. Practitioners in any doubt if they have complied should urgently contact the presiding Judge's Registrar.
 5. Owing to a trend in non-appearances, especially in cases where a bank is the applicant, in such matters the court will order that:
 - a. The matter is removed for non-appearance.
 - b. The matter shall not be re-enrolled unless the request for enrolment is accompanied by an affidavit from the attorney of record explaining the non-appearance at the previous hearing.
 - c. A court on a subsequent hearing shall enquire into whether the explanation is satisfactory, in particular, why a withdrawal of the case prior to final enrolment was not effected, and further whether the waste of a slot on the unopposed motion court which another litigant could have used to obtain an earlier hearing should not be visited with an appropriate punitive costs order or an order interdicting the legal representatives from recovering a fee for the work performed on the application.
 6. When moving their matters, counsel will be expected to hand up a draft order in hardcopy.
- Counsel are excused from introducing themselves in chambers.
