DIRECTIVE:

1. Counsel or Practitioners who have not appeared before the Judge may introduce themselves when their matters are called in Court.
2. Please be advised that there will be a roll call for all urgent matters before Ally AJ. The roll call will be conducted on Monday, 26 May 2025 in Open Court **at 10h00**).
3. All applications must be properly issued by the Registrar seated at the General Office in the High Court Building, except for applications brought outside of the ordinary court hours, before the secretary to Judge Twala (as the senior judge) is approached for the enrolment of applications.
4. The contact number for urgent applications to be heard **out of ordinary court hours** is **082 573 5233**. The number is **not to be used for general enquiries** or for any issue other than urgent applications to be heard **out of ordinary court hours**. **The phone will only be answered after normal court hours.**

5. Applications before Acting Judge Ally will be heard in **Open Court at 10h00 unless stipulated differently in consultation with the parties.**
6. Applications heard out of the ordinary court hours will be heard **via Microsoft Teams** at a time indicated by the Judge.
7. A ~~matter~~ **will be struck from the roll where parties have failed to file a Practice Note, unless there is good cause or exceptional circumstances exist.**
8. Draft orders must be duly completed and compliant (i.e. must contain the details of Counsel, reflect the date of the hearing, and the Judge's particulars). Draft orders must be uploaded onto Caselines/CourtOnline in PDF and Word format and Counsel must bring a physical copy to the hearing in court. This order must be signature ready.
9. Orders will be delivered by uploading same onto Caselines/CourtOnline. Parties with CourtOnline matters must follow the "7-Steps" to ensure that their CourtOnline matters bundle onto CaseLines.
10. Save with the leave of the Judge, no documents (save for heads of argument) may be uploaded after 12h00 on Sunday 25 May 2025.
11. Due to the time constraints imposed by the nature of urgent court, no consideration will be given to documents belatedly filed, **save in exceptional circumstances. A satisfactory explanation must be incorporated in the practice note.**
12. Parties must ensure that all papers necessary for the urgent hearing are uploaded by no later than Sunday, 25 May at 14h00.
13. **In all applications a Practice Note must be filed setting out the following:**
 - a. The grounds of urgency;
 - b. Nature of relief sought;
 - c. Total number of pages;
 - d. An indication which portion of the papers must be read;

- e. The estimated duration of the matter; and
- f. Contact details for the legal practitioners, which must include both cellphone numbers and email addresses.
14. In all opposed applications, heads of argument of Applicant parties in each matter must be uploaded by no later than **14h00 on Sunday 25 May 2025** and Respondents to file no later than **Monday, 26 May 2025 at 09h00**.
15. Service of process in all urgent applications shall comply with the Rules of Court. Where an agreement was reached by all the representatives of all parties to vary the requirements of the Rules to facilitate a wholly electronic exchange of papers, this must be specifically stated in the practice note.
16. Where parties have settled the matter, the Judge's Secretary must be notified immediately.
