3. The Opposed roll will proceed as soon as the court has dealt with the Unopposed roll.
4. Parties are requested to bring hard copies of **ALL documents** to be used in court to Mr T Manganyi at **chambers 904 by no later than Tuesday, 20 May 2025 at 09h00**.

6. Parties are to hand up the draft order in court **IMMEDIATELY AFTER** the order has been granted as to avoid court orders being signed after the hearing date.
7. In matters where there is no bundle created on Caselines, there are no documents before the Judge, the matter will therefore be removed from the roll for non-compliance with the directives.
