DIRECTIVE:

- All matters will be heard online. The link can be found on the last page of this roll.
- Should any party not be able to use an online platform they may access the virtual hearing at the High Court where facilities are in place.
- All unopposed matters will be heard on Monday 21 July 2025. Due to the difficulty of ascertaining seniority in an online hearing, the unopposed roll will be heard in the order of numbering on the roll. However, senior counsel, if any, may mention an unopposed matter at 10.00am or as soon as they are ready to call the matter on Monday, 21 July 2025.
- The opposed roll shall be heard on the dates and times reflected below in respect of each matter. If any party has an insurmountable difficulty on the date and time allocated they are to immediately contact the Judge's secretary and provide reasons why they are not available on the date and time allocated and the Judge will endeavour to make alternative arrangements if reasonably possible and the parties will be advised accordingly.
- However, parties are to bear in mind that no parties have indicated a preference for any particular date in their practice notes.
- Legal representatives for parties in the opposed matters allocated for hearing on a particular day of the week are to remain available and contactable via their cellular numbers in the event that an earlier matter is completed sooner than the estimated duration in which event the next matter may be called earlier than the allocated time.
