2. The Unopposed Family Court Roll will be disposed of on **Monday, 21 July 2025** commencing at 10h00. Matters will be called numerically, i.e in the order they appear on the roll.
3. The Opposed Family Court Roll will be in accordance with the allocations made and as published on the JSA website (see 1 above).
4. Unless otherwise indicated, Urgent Applications will be heard on **Tuesday, 22 July 2025** in accordance with the allocations made and as published on the JSA website (see 1 above).
5. Introductions will be done in open Court as Counsel call their matters.
6. Matters with the note “not accessible” have no bundle/accessible bundle on Caselines. These will be removed from the roll for non-compliance unless the non-compliance is rectified by **12h00 on Thursday, 17 July 2025**
7. Practice notes (updated and of a joint nature where applicable) are to be uploaded on Caselines by no later than **12h00 on Thursday, 17 July 2025**. Practice notes must contain full details of counsel and attorneys as per the JP’s Consolidated Practice Directives.
8. Parties are to ensure that in all opposed matters, heads of argument have been filed in accordance with the prevailing practice directives of this Division.
9. Draft orders must reflect the date, the name of the presiding officer, details of the attorney and counsel appearing. Orders must be “signature-ready”. Parties are to delete the words “further and/or alternative relief” and remove the word “draft” within the tramlines.
10. There must be strict compliance with the prevailing practice directives of this division as applicable to urgent applications.
11. The allocation of a hearing date and time to an urgent application does not automatically translate into such application being regarded as urgent.
