DIRECTIVES:

1. All matters on the roll, unopposed and opposed, are to be thoroughly checked by the parties' respective legal representatives who are to ensure that their matters are in order and accessible to the Court on caselines by no later than **noon on Thursday 17 July 2025**. Should this not occur the matter will not be heard and will be removed from the roll.
2. Further to the above, practice notes, heads of argument (in opposed matters) and draft orders are to be uploaded to caselines by no later than **noon on Thursday 17 July 2025**. Draft orders in word format are to be emailed to the judge's secretary. 1 hard copy is to be brought to court for Unopposed and Opposed Matters. 2 Copies for Urgent Family Court matters.
3. In respect of all unopposed matters, practitioners are to ensure that the returns of service are similarly uploaded to caselines. Failure to do so will result in the matter being removed / struck from the roll.
4. Failure to adhere to any of the above may result in the matter not being heard and being removed from the roll.
5. **Hard copies printed off caselines in all opposed matters** are to be delivered to office 508 on the fifth floor **by no later than noon on Thursday 17 July 2025**. Please provide hard copies of unreported decisions referred to by counsel in heads of argument together with the papers filed of record.
6. As below, ALL unopposed matters will be heard in open court on Monday 21 July 2025 at 10h00. Court room details will be provided by the DJP's office via the JSA website and on SAFLII.
7. A further roll in respect of the allocations of opposed matters will be provided as soon as possible. Practitioners in opposed matters can assume they will be heard on either Wednesday 23 July 2025 or Thursday 24 July 2025 in open court.
8. Urgent applications will be heard in open court on Tuesday 22 July 2025 unless otherwise indicated.
