DIRECTIVE

FAMILY COURT BEFORE BADENHORST AJ

TERM 3 – WEEK 2

Week of 28 July 2025 – 1 Aug 2025

1. Kindly note that all family court matters which will be before Madam Justice Badenhorst, AJ will be heard in **open court at 10h00am** unless otherwise directed. (Please see the day-roll for the court that will be used for the hearing).
2. All introductions will be done in court.
3. Matters have been allocated as per the roll below and counsel need only appear on the day allocated.
4. Only 1 draft order is required to be handed up. Where a settlement agreement is to be made an order of court, **a hard copy of the settlement agreement (marked X) together with the hard copy of the draft order** sought, must be handed up.
5. Draft Orders must comply with the Directive, including identifying the Presiding Judge, the date of the hearing and the court room. The Draft Order should also include the following:

“This order is made and order of court by the Judge whose name is reflected herein, duly stamped by the registrar of the court, and is submitted electronically to the parties/their legal representatives by e-mail. This order is further uploaded to the electronic file of this matter on Caselines by the Judge or the Judge’s secretary. The date of this order is deemed to be the date of hearing of the matter_____.”

6. The general Family Court Directives are to be complied with:

- 6.1. A practice note stating the full particulars of counsel and attorneys, the nature of the application, the issues to be decided and estimation of time duration must be uploaded.
- 6.2. In Divorce proceedings certified copies of the marriage certificate and settlement agreement should be uploaded.
- 6.3. Proof must be provided that the **Notice of Set Down** was served on the Defendant / Respondent.
- 6.4. Heads of argument should be filed in opposed matters before Friday, 25 July 2025 at 10h00.

7. **UNOPPOSED DIVORCES:**

- 7.1. In divorce matters where there are **no minor children**, no oral evidence by Plaintiff/Defendant is required. (If the Plaintiff did not upload an Evidence Affidavit, oral evidence should be led)
- 7.2. In divorce matters where **minor children are involved**, the Plaintiff (or Defendant), must appear in open court to give oral evidence.
