- [1] All matters will be heard in OPEN COURT.
- [2] If cases were not ready at the time of filing **at 12:00 on Thursday, 31 July 2025** (i.e. all relevant affidavits filed and the case indexed and paginated) and where no link has been received, the matter will be struck from the roll, they will not be heard, unless there is good cause or exceptional circumstances.
- [3] A practice note must be filed on Caselines setting out the following:
  - 2.1. The grounds for urgency;
  - 2.2. Nature of relief sought;
  - 2.3. Total number of pages;
  - 2.4. An indication which portion of the papers must be read and which not;
  - 2.5. The estimated duration of the matter;
  - 2.6. If there is non-compliance with the practice directives for urgent court reasons, for such deviation;
  - 2.7. Contact details for the legal practitioners, which must include both cell phone numbers and email addresses.
- [4] Where no practice note has been filed, the matter may be struck from the roll unless good cause is shown for non-compliance as per the issued directive.

- [5] In all opposed matters, heads of argument must be filed by both parties before **14h00 on Monday, 4 August 2025**. Strict adherence will be observed to the rules of urgency. As the profiles will be frozen, please email the heads of argument to [TsMpuu@judiciary.org.za](mailto:TsMpuu@judiciary.org.za).
- [6] If there is non-compliance with the practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- [7] There **will be roll-call** on Tuesday, **05 August 2025, in court 4C at 10:00**.
- [8] An allocation does not mean that the matter is considered sufficiently urgent to be heard on the merits. Submissions will need to be made regarding the grounds of urgency.
