DIRECTIVE:

- All matters will be heard in physical court.
- All unopposed matters (save for this which have a return day of 12 August 2025) will be heard on Monday 11 August 2025 from 10h00. Matters on the unopposed roll will be called in order of seniority.
- The opposed roll shall be heard on the dates and times reflected below in respect of each matter. If any party has an insurmountable difficulty on the date and time allocated they are to immediately contact the Judge's secretary and provide reasons why they are not available on the date and time allocated and the Judge will endeavour to make alternative arrangements if reasonably possible and the parties will be advised accordingly.
- Legal representatives for parties in the opposed matters allocated for hearing on a particular day of the week are to remain available and contactable via their cellular numbers in the event that an earlier matter is completed sooner than the estimated duration in which event the next matter may be called earlier than the allocated time.
- NB: please note that all unopposed matters set down in the IMC before Rome AJ for the week of 11 August 2025 to 15 August 2025 which have a return day for Tuesday 12 August 2025 will be heard on Tuesday 12 August 2025 at 10h00 and not on Monday 11 August 2025. All the remaining unopposed matters will be heard on Monday 11 August 2025 as per the directive above.
