Directives for the Opposed Motions Roll (week 8):

1. Introductions will be done in chambers 310/311 from 09:45.
2. Practitioners must file their practice notes by noon on **Friday, 5 September 2025.**
3. Practitioners must ensure compliance with the **relevant practice directives** pertaining to opposed motion court.

4. Practitioners are required to use the **'Widely Shared Note'** to advise the Judge of any issues or matters that she should be apprised of before reading the papers.
5. Practitioners must provide the court with **ONE** hard copy of the draft order and the same should be uploaded in pdf and word on Caselines at least one day prior to the matter being called. Draft orders should indicate when the matter will be heard, the Judge's name (i.e., Amien AJ) and the manner in which the matter will be heard (i.e., open court). At the end of the draft order, the name and details of both counsel / practitioner and that of their instructing attorneys must be included.
6. Practitioners must ensure that the correct information appears on the draft order before same is uploaded onto Caselines and handed to court. Any errors appearing on the draft order, which is the fault of practitioners will have to amended by way of an application for variation.
7. Matters will be heard in open court before Amien AJ unless otherwise arranged with the judge.
8. Practitioners are expected to attend at the judge's chambers at 09h45 for the purpose of introducing themselves.
