1. **All** matters will be heard in open Court.
2. Introductions is from 9h30 to 9h45 at Judges Chambers Room 305
3. **All** matters where there are minor children must have an endorsement from the Family Advocate and *viva voce* evidence will be lead, if not the matter will be removed from the roll.
4. **All** matters must have the **original** settlement agreement (where applicable) and marriage certificate available at Court.
5. **All** matters where there is a settlement agreement and there are **no** minor children, can proceed on evidence affidavit.
6. If there is noncompliance with the Consolidated Practice Directive applicable to Family Court, , **matter will be struck of the roll with costs.**
7. Legal practitioners must ensure that all relevant documents, including draft order is uploaded on Caselines **before 16h00 on Thursday 11 September 2025**
8. **TAKE NOTE AS TO THE SPELLING OF THE JUDGE'S SURNAME WHICH SHOULD BE: Before Her Ladyship KRÚGER AJ,** in respect of the draft order of which two copies will be required to be handed up.
9. Unopposed divorces where there is **no** settlement agreements will require *viva voce* evidence to be lead.

10. Please ensure that the draft order contains **the details of the Judge, date, number on the roll, Court number, details of the parties, correct case number and the details of the legal practitioner(s).**

11. Matters where there which does not have the relevant documents uploaded or is not accessible on Caselines by 16h00 on Thursday 11 September 2025, will be struck from the roll.
