3. Kindly note: all court proceedings are recorded.
4. Please bring a hard copy of a draft order to court and upload one on case lines.
Plaintiffs in unopposed divorce matters may not appear in person where an affidavit is uploaded as evidence on caselines.

5. If such affidavit has been uploaded, then the plaintiff must be in court to provide oral testimony.
6. The Family Advocate report or endorsement must be uploaded on caselines.
7. The court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact the enrolment office.
8. Kindly note introductions will be done in court.
9. Please be mindful of the spelling of the Honourable Justice's surname, it is **NKOSI.**
10. **Practice note must be uploaded on caselines in all matters within the time period specified by the practice manual.**
