DIRECTIVES:

3. The matters will be called by seniority.
4. Counsel intending to remove matters must ensure that a notice of removal is uploaded on Case Lines and inform the secretary on email of the removal.

5. Counsel involved in other matters and who may require matters to stand down must inform the secretary of this request on email or inform the secretary before the start of court proceedings.
6. All Draft Orders are to comply with the Manual and Directives, including the names of counsel and names and contact details of instructing attorneys. Draft order must include the names of the parties, name of the judge, date of the hearing and correct case number. Hard copies of draft orders should be available in court.
7. In matters where parties have signed a settlement agreement, Draft orders must be accompanied by the signed settlement agreement.
8. Parties appearing in matters highlighted in red should attend to creating the Case Line bundle and/or inviting the secretary before 16:00 on 06 November 2025. Once a bundle has been created or an invitation sent, parties must ensure that they notify the secretary immediately.
