Good day Ladies and Gentlemen

Re: Directive in the Insolvency Court in front of DU Plessis J et Miltz AJ for week of 17 to 21 November 2025

Judge Du Plessis and Acting Judge Miltz are sitting in the Insolvency Court during the week of 17 to 21 November 2025.

Judge Du Plessis is the senior judge in the Insolvency Court for that week.

I have uploaded onto Caselines a copy of the full roll where the matters in front of Judge Du Plessis and Acting Judge Miltz for that week are indicated.

Fresh Practice Notes, Draft Orders (in Word format), Updated Heads of Argument (if the matters are of a complex nature) and / or any settlement agreements, with any annexures that are referred to in the draft order, must be uploaded onto **Court Online** and **emailed** to me by **Tuesday 4 November 2025 at 16h00**.

Parties need to email to my work email address (mmoolman@judiciary.org.za) and please CC my private email (mornayluke@gmail.com) and upload onto Court Online the following before Tuesday 4 November 2025 at 16h00 :

- A copy of the Proposed draft order in Word format containing the Judges name, the date of hearing and all other relevant information and or any Settlement agreements and all the annexures referred to in the draft order;
- An Updated Practice Note from the Applicant and the Respondent (if the matter is on the opposed roll) containing an estimated duration of the matter and a brief background to the matter as well as counsel's details. Please take note that the court will apply strict time periods;
- Updated Heads of Argument from both the applicant and respondent (if the matter is on the opposed roll) referring to the correct Caselines numbering when referring to papers in the record.

Please create a section 000 on Caselines on each matter where the parties need to upload their Practice Notes, proposed draft orders in Word format, and also any heads.

If your matter has been initiated on Court Online please ensure that the papers are correctly indexed there otherwise, they will not reflect on Caselines for Judge Du Plessis to read and adjudicate upon.

Please make sure that the fresh Practice Notes, draft orders on Word format and Heads of Argument (if needed) have to be uploaded to Court Online and indexed and emailed to me.

The Judge will, after receiving the documents from the parties, do a further daily time allocation of the matters.

I have noticed that there are several applications (**matters S3, S13, S17, S21, S30. S39 and S48**) that were initiated on Court Online that **don't have files or the files are empty on Caselines** or the files on Caselines are empty. Please ensure this is corrected as soon as possible.

Without the Caselines file the judge cannot adjudicate the matters.

Please ensure that the details of the counsel that is moving the matter is at the bottom of the draft as per the Practice Manual.

Also find attached hereto an example of how your draft orders have to be formatted. Please make sure your draft orders are in the same format as the example.
