FURTHER DIRECTIVES (Monday, 24 November 2025, 13h10)

1. The final allocations of the matters before Moultrie AJ in urgent court for week 8 of Term 4 are set out below. Parties in matters allocated other than at 10h00 on 25 November 2025 need not attend court at that time (notwithstanding the content of any Notice of Motion).
2. Any further documents sought to be delivered by any party must be both (i) uploaded onto the CaseLines hearing bundle; and (ii) emailed to the Judge's secretary at the email address above. In addition, save in exceptional instances (which must be explained in the email), such documents must have been duly filed via the CourtOnline registry before uploading to CaseLines and emailed, and the document uploaded to CaseLines and emailed must be the version that was filed on CourtOnline (i.e. including the CourtOnline cover sheet showing time of filing). Representatives must ensure that the uploading of any document to the CaseLines hearing bundle does not affect the pagination of any other document in the bundle as at the time of uploading.
3. Further or amended directions may be published via "widely shared notes" posted on the CaseLines hearing bundle. Should responses be requested, parties are required to respond without delay.
4. Any party becoming aware of any fact that may affect the smooth operation of the court (including any settlement or withdrawal) must contact the judge's secretary, copying the legal representatives of the other parties (if any), as soon as they become aware of such fact.
5. Failure to comply may result in adverse costs orders.
