DIRECTIVE AND ALLOCATED FAMILY COURT ROLL: 01 – 05 DECEMBER 2025

BEFORE THE HONOURABLE JUSTICE COURTENAY AJ.

AMENDED DIRECTIVE:

1. HEARING: [THIS APPLIES IN RESPECT OF ALL MATTERS]

- 1.1 All matters will be heard in **OPEN COURT** at 10:00 am.
- 1.2 Introductions will be done in open court as and when counsel call their matters.
- 1.3 All matters, unless directed otherwise, will be called in order of seniority.
- 1.4 In every matter proof must be provided that the notice of set down was served on the defendant/respondent and that the defendant/respondent is aware of the date for hearing.

2. DRAFT ORDERS: [THIS APPLIES IN RESPECT OF ALL MATTERS]

- 2.1 All draft orders, which must include the date, the name of the judge, and the details of the attorney of record and the counsel appearing, must be handed up to the court and uploaded to CaseLines. These orders should

be “**signature ready**” and should not contain terms such as “**further and/or alternative relief**” or “**draft**”.

2.2 It is the responsibility of the applicant’s attorney to ensure that the matter is **TIMEOUSLY, PROPERLY AND COMPLIANTLY** uploaded onto CaseLines in accordance with the Practice Directive. Late filing or updates will not be accepted.

2.3 **NO FURTHER DOCUMENTS MAY BE UPLOADED TO CASELINES AFTER 13H00 ON FRIDAY, 28 NOVEMBER 2025 AND CASELINES WILL BE FROZEN BY THE REGISTRAR.**

3. **UNOPPOSED DIVORCES:**

3.1 All unopposed divorces will be heard on **Monday, 01 December 2025, at 10h00.**

3.2 In divorce matters in which there are no minor children involved (category A) the matters will be disposed of in **OPEN COURT** by adducing evidence on affidavit.

3.3 In divorce matters in which there are minor children involved (category B) the matters will be disposed of in **OPEN COURT** by adducing the oral evidence of the Plaintiff (or Defendant, if applicable).

3.4 All draft orders (per paragraph 2 of these directives) must be accompanied by a certified copy of the settlement agreement, where applicable.

4. **OTHER UNOPPOSED MATTERS:**

4.1 All “**unopposed other family matters**” will be heard on **Monday, 01 December 2025 at 11h30.**

4.2 All matters must comply strictly with these directives and the Consolidated Practice Directive.

5. **URGENT MATTERS:**

5.1 All urgent matters will be heard on **Tuesday, 02 December 2025 at 10h00.**

- 5.2 All matters must comply strictly with these directives and the Consolidated Practice Directive.

6 **RULE 43 APPLICATIONS:**

- 6.1 All “**Opposed Rule 43**” will be heard on Wednesday, 03 December 2025 as follows –
- 6.1.1 **matter number 24 will be heard at 10h00.**
 - 6.1.2 **matter number 26 will be heard at 11h30.**
 - 6.1.3 **matter number 28 will be heard at 14h00.**
- 6.2 In the event of a matter settling, the Registrar must be notified as soon as practicably possible.
- 6.3 Parties are strongly encouraged to engage each other with a view to, at the very least, narrowing the issues.
- 6.4 All matters must comply strictly with these directives and the Consolidated Practice Directive.

7 **OTHER MATTERS:**

- 7.1 All other matters, inclusive of **matter 42**, will be heard **on Thursday at 10h00.**
- 7.2 All matters must comply strictly with these directives and the Consolidated Practice Directive.
