BEFORE HONOURABLE ACTING JUDGE MOJAPPELO INSOLEVENCY.

1. Unless directed otherwise, matters will be heard in open court to commence at **10h00** (court to be allocated).
2. Any urgent insolvency matters are to be referred to MANAMELA J.
3. Introductions will take place at Office number **_(1.1)_ at 9h30.**
4. Applications will be heard in open court on the date and at the time reflected on the attached court roll. Legal practitioners are to appear on those days.
5. Removals, postponements and settlements will be called first, and matters will thereafter be called in preference to seniority of counsel appearing in the matter.

6. Legal practitioners must upload and send the draft order(s) in relation to their matters in Word format to TFKekana@judiciary.org.za.
7. All court documents are to be uploaded by no later than 16h00, two days prior to the hearing date, which documents are to include, in respect of each (opposed and unopposed) matter, an updated practice note (i) confirming the identity and contact details of counsel appearing in the matter, together with the details of the relevant instructing attorney; (ii) indicating whether the matter is opposed or unopposed; (iii) briefly setting out the nature of the matter and (iv) if it is the case, stating that the application papers are in order, that the jurisdictional requirements for the relief sought in terms of the application have been satisfied and that a proper case has been made out for the relief sought in terms of the application to be granted. Failure to comply may cause the matter to be removed from the roll.
8. In all opposed matters set down for hearing during the week of 20 April 2026, heads of argument (original or supplementary) are to be uploaded no later than 16h00, two days preceding the hearing date in respect of the application concerned. Failure to comply may cause the matter to be removed from the roll.
9. Draft court orders must be uploaded prior to commencement of the hearing.
10. Parties are requested to bring two hard / printed copies of the draft order to be handed up in court.
11. Complete details of the parties' representatives (including Counsel), judge's name (MOJAPELO AJ), date of hearing, manner in which the matter is heard and Court number (if applicable) must be included in the draft order.

12. The following disclaimer/qualification should be included in every draft order: *“This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or his/her Secretary. The date of this Order is deemed to be _____.”*
