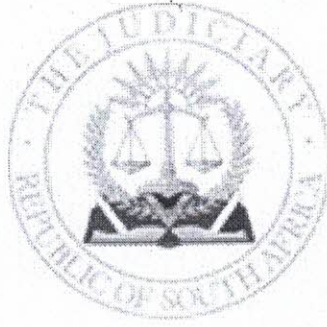

**PRACTICE DIRECTIVE: DEFAULT JUDGMENT MATTERS BEFORE THE
HONOURABLE JUSTICE PILLAY AJ (Ms.): 3 – 7 AUGUST 2026.**

The default judgment roll will be dealt with as follows:

1. The default judgment matters scheduled for the week of 3-7 August 2026 will be heard in open court, unless otherwise indicated, at the specific times listed on the attached roll.
2. Any settlement, removal, or request for postponement must be communicated to the Judge's secretary, Mr. Livhuwani Mudau, at LivMudau@judiciary.org.za as soon as possible.
3. Matters must comply with the Practice Directives and this Directive, and be properly uploaded/bundled to Caselines, or they may be struck off the roll.
4. Introductions will be done in Open Court.

5. Draft orders must contain the date of the hearing, the Judge's particulars [PILLAY AJ]. They must reflect the words "Court Order" not "Draft Order" and "further and/or alternative relief" must be DELETED. They must be uploaded onto Caselines. Counsel must bring one physical copy to the hearing in court and have a Word version ready for email to the Judge's secretary in case of amendments. They must be typed in Arial font size 12 with 1.5 spacing.
6. The Judge's secretary cannot assist with any Court Online or Caselines issues. Problems must be referred to the Court Online helpdesk at CourtOnlineSupport@judiciary.org.za. Parties with Court Online matters must follow the "7-Steps" to ensure that their Court Online matters bundle onto Caselines.

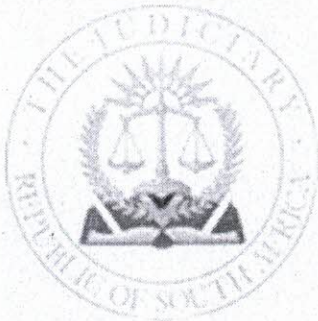
